REQUIREMENTS FOR DISPLAYING ARTWORK

Deliver all artwork on the date and within the window of time that Show Chair request.

1. All inventory must be entered into Square prior to or while delivering work to the gallery. Refer to Square How-to Manual for naming format.
2. The entry fee for each juried show will be set prior to the show and must accompany the works brought for exhibition. Except for cards, any work displayed during a juried show by a member must be accompanied by the entry fee. This includes Unframed Artwork, 3D and Jewelry.
3. The decision as to the works to be displayed in a juried show is entirely up to the juror for that show.
4. No 2D Wall Art may be displayed in a show that has been displayed in a prior show less than six months before. The exceptions to this rule are the Holiday Art and Gift Market, the \$100 or Less Show or one of a similar nature. In addition, any work shown in any show that lasts two weeks or less (a Short Show) may be entered one time in any other show within the six month period following the Short Show. This rule does not include works displayed in the Littleton Fine Arts Guild shows held outside of the Depot Art Gallery or at the Outdoor Art Market.
5. All 2D must either be framed or must have finished edges. Artwork that is presented without a frame on stretched **deep** canvas or cradled substrate, must be **1-3/8" or more**, no staples may show. This includes photography on canvas.
6. All 2D must use wire as the hanging medium. Saw-tooth hangers or metal eyes are unacceptable.
7. Unframed Artwork must be completely covered and properly secured, with clear acetate. Artwork Label is placed on the back (**not the front**). Refer to Unframed Artwork & 3D Guidelines for more instructions.
8. Three dimensional works, such as pottery or sculpture, must be able to stand or rest on their own stably. Otherwise, they must be accompanied by display stands.
9. All works displayed must be for sale.
10. When a work from a juried show is sold, the artist will be allowed to replace it. Such works will be marked with a yellow dot, indicating that it is an un-juried replacement.
11. All artwork must be accompanied by two Artwork Labels, disclosing the following: The artist's name and phone number, artistic medium (oils, pottery, photograph, etc.), title of the work, and the price of the work.

One label shall be permanently attached to the back of the piece. The other shall be temporarily attached to the front of the piece and is removed when the title card for the piece is placed on the wall or the surface on which it is located.

Plases Remember:

All artwork displayed for a show must be the original work of the member. Reproductions are not allowed for show displays except for original photographs and digital art, and for Unframed Artwork. An original work (a) is not a mechanical or computerized reproduction of one or more of the member's pieces of art (such as a giclée), except for photographs; (b) is not, taken as a whole, substantially a copy of the work of another artist; or (c) a composition created or directed by a teacher or workshop instructor. If in doubt, the member should consult the Littleton Fine Arts Guild president.
